- ◇ Enclose a **non-refundable \$20 jury fee** check or money order made payable to GMAHS/Art Affaire. **DO NOT send booth fee** unless you are eligible for direct application (see ***Exception** note at right). *If accepted*, you will be notified of booth fee submission requirements.

Important Notes for Applicants

To participate in the jury process and for the best opportunity of acceptance, your completed submission and jury fee must be **received no later than April 20, 2018**.

Applications will be reviewed as long as space or category balancing allow. ALL applications require a \$20 jury fee even if submitted after the April 20 deadline.

Artists accepted for Art Affaire will be notified by email and each accepted artist must then **submit an \$80 booth fee within 14 days** of notification. *Please do not send the booth fee until after you are notified of acceptance.*

***EXCEPTION and great news for 2017 Art Affaire award winners!** 2017 Art Affaire award winners (Best of Show, 1st or 2nd places) are *excused* from the \$20 jury fee and process, but **MUST submit three images** for promotional purposes and **pay the \$80 booth fee by the April 20** deadline to secure/confirm space. *Note: does not apply to honorable mention recipients.*
